- FACILITY:** Competition will be held in (1) Eight Lane, 25-yard course in the DYNA Dome pool (start and turn depth for the meter pool is 7 feet on both sides), and (1) Ten Lane, 25-yard course in the indoor pool (6 ½ feet deep on both start and turn ends). Also available for warm up/warm-down, as designated, are 5 lane indoor pool and designated lanes in the outdoor pool. Bleacher seating is provided. No chairs will be allowed on deck by order of the DeKalb County Fire Marshall. Concessions will be available.  
*The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming & Georgia Swimming.*

- ELIGIBILITY:** Open to all swimmers and teams registered with U.S.A. Swimming. Out-of State teams should be prepared to submit proof of current U.S.A. Swimming Membership for each swimmer entered, if requested by the sponsoring team. No unregistered swimmers will be permitted to compete in this meet. Dynamo will accept USA registrations at the meet. You must have a check for \$59.00 made out to "Georgia Swimming" to register, plus \$25 penalty if you are a late renewing swimmer. All teams must sign the waiver on the Summary Sheet stating that all swimmers and coaches participating in this meet are currently registered with U.S.A. Swimming.
- RULES:** All Swimmers, Coaches and Officials must be currently registered with USA Swimming. It is the requirement of USA Swimming that **ALL OFFICIALS and COACHES** wear their current USA Swimming registration card while on deck. All swimmers are responsible for swimming in their assigned heats and lanes. Current USA Swimming rules will govern the conduct of the meet unless otherwise noted.  
  
**"Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement."**
- SCRATCH RULE:** The current (04/18/2010) Georgia Swimming Scratch Rule will be in effect.
- WARM-UP:** The Georgia Swimming approved warm-up guidelines will be followed for this meet. Warm-up lane assignments will be posted at the pool, and each team will be required to furnish at least one USA Swimming Certified Coach to monitor their swimmers.
- FORMAT:** All 10 & Under events will be Timed Finals. All other events will be conducted on a Preliminary & Final basis, with the exception of the 400 IM, 500 Free, 1650 Free, 11-12 200 Back, 11-12 200 Breast, 11-12 200 Fly and **all of Friday's events**; which are Timed Finals events.  
  
The 400 IM, 500 Free, 1650 Free, 11-12 200 Back, 11-12 200 Breast and 11-12 200 Fly will be **deck seeded** events, requiring **positive check-in**. All other events will be pre-seeded. Dynamo reserves the right to run multiple courses if the timeline warrants it.

**FINALS/CONSOLS:** All 11-12, 13-14, and Senior events **except** those events swum on Friday and the 400 IM, 1650 Free, 11-12 200 Back, 200 Breast and 200 Fly; will have a championship and a consolation heat in finals.

**DISTANCE EVENTS: Each swimmer in the 500 Free, and 1650 Free must supply counter.**

**CHECK-IN:** In order to be seeded into the deck seeded events, swimmers must positively check in with the Clerk of Course according to the following schedule:

**1650 FREE:** This event will be limited to the fastest 40 seeded times in both the 11-14 women's and the 11-14 men's event (a maximum of four heats of each). The Seniors will be limited to the fastest 20 seeded times in the women's and men's events (a maximum of two heats each). The Preliminary heats will be swum alternating women and men, fastest to slowest; within age group; Seniors Women/Men until complete and then 11-14 Women/Men. Dynamo reserves the right to conduct the 1650 in multiple pools, if necessary, to manage the timeline. If a second course is needed, it may be necessary to use watch times for that course and eliminate alternating by genders.

**11-12 200 Back; 200 Breast; 200 Fly:** The 11-12 200 Back, 200 Breast, 200 Fly will be conducted as a timed final event. The fastest seeded heat of the 200 Fly will swim during the Finals session with all other heats being contested during prelims.

**400 IM:** This event will be limited to the fastest 60 seeded times in both the 11-14 girls' and the 11-14 boys' event (a maximum of six heats of each) and limited to the fastest 30 Seniors in both the women's and men's event (a maximum of 3 heats of each). The fastest heat of each will be swum as part of that evening's Finals Session. The Preliminary heats of the 400 IM will be swum, in event order, fastest to slowest.

**500 FREE:** The 10 & Under, 11-14 and Senior 500 Free will each be limited to the fastest 40 seeded times in each age group, in both girls' and boys' events (a maximum of four heats of each). Dynamo reserves the right to conduct the 500 in multiple pools, if necessary, to manage the timeline. If a second course is needed, it may be necessary to use watch times for that course.

The 10-Un 500's will be swum slowest to fastest in event order.

The 11-14 and Senior 500's will be swum fastest to slowest, alternating women and men, fastest to slowest; within age group; Seniors Women/Men until complete and then 11-14 Women/Men.

- ENTRY LIMIT:** **THE MEET WILL BE LIMITED TO THE FIRST 600 SWIMMERS FROM WHOM ENTRIES ARE RECEIVED.** The 11-14/Senior morning session will be limited to 450 swimmers.  
11 & over swimmers may enter three (3) individual events per day.  
10 & under swimmers may enter up to five (5) individual events per day.
- ENTRY FORMS:** All entries MUST include the USA Swimming Club Code and each swimmer's USA Swimming registration number, first and last name, age and seedtime for each event entered. Each team must complete the Meet Entry Summary Sheet. A printed copy of all entries, fees and a completed and signed liability release form must accompany your entries. Meet set-up is available for all HYTEK-Team Managers for Windows users at the Dynamo Swim Club Web Page: <http://dynamoswimclub.com>.  
Entries should be emailed, provided your entry hard copy, fees and liability release form are received by the entry deadline. E-mail entries must be accompanied by a word file of the entries so we can verify proper import of your swimmers. You will receive an E-mail verification that your entries have been received within 8 hours of submission.

- ENTRY DEADLINE:** All entries must be received on or before Monday, November 7, 2011. Only the first 600 swimmers will be accepted, as received at the following address, **FAX or phone entries cannot be accepted:**

- ENTRY FEES:** Four dollars (\$4.00) per event. Georgia Swimming, Inc. requires a two dollar (\$2.00) surcharge per swimmer for all out-of Georgia LSC swimmers. Make checks payable to: **DYNAMO PARENTS' CLUB**. Entries will not be accepted unless accompanied by the correct fees.
- LATE ENTRIES:** No entries from new swimmers will be accepted once the 600-swimmer limit is reached. Late entries from swimmers already accepted into the meet will be permitted only if open lanes exist. Late entries will be seeded as NT. Late entry fees are double (\$8.00) the standard entry fee, and are payable immediately. No late entries will be accepted that require additional heats to be created.
- AWARDS:** Medals for 1<sup>st</sup> through 3<sup>rd</sup> place, and ribbons for 4<sup>th</sup> through 10<sup>th</sup> place in each event. The 400IM, 500 and the 1650 will be swum as 11-14, but awarded as 11-12 and 13-14.
- LIABILITY RELEASE:** In granting this Sanction it is understood and agreed that, USA Swimming, Inc., Georgia Swimming, Inc and the Dynamo Swim Club shall be free and held harmless from any and all liabilities or claims for damages arising by reason of injury to anyone during the conduct of the event. Acceptance of this policy is evidenced by entry into this meet.
- MANDATORY COACHES MEETING:** Coaches must sign in and show their current U.S.A. Swimming Registration Card. Coaches must wear their current Registration Card at all times while at the meet.  
**Any coaches not having a current certification will be barred from the pool deck.**  
Coaches are reminded to closely supervise their swimmers at all times. At least one Coach from each team must attend a Coaches Meeting at 2:15 PM on Friday, November 18<sup>th</sup>, in the Hospitality Room.

**OFFICIALS:**

The Dynamo Swim Club welcomes and encourages the assistance of certified officials (and apprentices when capacity allows) from visiting teams. To volunteer, please notify the Meet Referee one hour before each session. Officials (and apprentices) should be prepared to present their LSC certification card, and to present and wear at all times, while working on Deck or in Hospitality, their USA Swimming registration card. Standard dress for officials is blue pants, shorts or skirt; white polo shirt and white shoes and socks.

**GEORGIA SWIMMING INC.**  
**SCRATCH RULE**

The Scratch Rule used in all meets in Georgia where the meet format includes preliminary heats, consolation finals, and finals, is the same "Scratch Rule" as found in Section 207.12 Administrative Conduct of USA Swimming Championships, of the 2010 USA Swimming Rules and Regulations. Certain Georgia LSC additions listed below apply to all timed final meets as well.

“207.12.6.D. Scratching from finals:

- (1) Any swimmer qualifying for a C, B, or A (bonus and consolation final or) final race in an individual event who fails to compete in said final shall be barred from further competition for the remainder of the meet, except as noted in paragraph E. A declared false start under 101.1.3F or deliberate delay of meet under 101.1.5 is not permitted and will be regarded as a failure to compete.
- (2) In the event of withdrawal or barring of a swimmer from competition the Referee shall fill the C, B, or A (bonus and consolation final or) final, when possible, with the next qualified swimmer(s). First and second alternates shall be announced along with the final qualifiers. These alternates shall not be penalized if unavailable to compete in the finals.
- (3) Where C and B (bonus and consolation) finals have not been swum and a barring or withdrawal is known to the Referee, the Referee shall reseed the C, B, or A (bonus final, consolation final and the) final, if necessary, to insert the alternate(s) in the appropriate lane(s), filling all lanes in the final.
- (4) If the C or B (bonus and consolation) final has already been contested, the (championship) final shall be swum without reseeding for the empty lane(s).

E. Exceptions for failure to compete – No penalty shall apply for failure to withdraw or compete in an individual event if:

- (1) The Referee is notified in the event of illness or injury and accepts the proof thereof.
- (2) A swimmer qualifying for a C, B or A (bonus or consolation final or) final race based upon the results of the preliminaries notifies the Referee within thirty (30) minutes after announcement of the qualifiers for that race that they may not intend to compete and further declares their final intentions within thirty (30) minutes following their last individual preliminary event.
- (3) It is determined by the Referee that failure to compete is caused by circumstances beyond the control of the swimmer.”

Georgia LSC Additions:

***Unless otherwise stated in the final sanctioned Meet Information:***

1. Swimmers that qualify for any additional heats beyond the above mentioned “C, B and A” final heats as announced in the Meet Information will also be subject to the above rules concerning scratching from finals.
2. In all deck seeded events, a swimmer who has checked in, been seeded and fails to compete in said event, shall be barred from his or her next individual event, except as noted in section E above. This rule also applies in timed finals meets where the meet management has placed limits on the number of heats to be contested or the number of individual entries to be accepted for deck-seeded events.
3. There is no scratch rule governing relays and there is no penalty regarding relay scratches.
4. Qualifiers for all finals heats and the first and second alternates are those as identified on the original results of the preliminary heat. Any qualifier who has moved up into this group as a result of the posting of corrected preliminary results after original results have been posted shall not be subject to penalty.
5. The meet official designated to receive initial intentions not to compete and final intentions shall be announced at the beginning of each session. It is suggested that this official be the Clerk of Course.
6. On the final day of LSC Championship competitions, any swimmer who has checked in for finals and fails to compete will be assessed a \$50 fine. This fine must be paid before the next LSC Championship meet in which the swimmer intends to compete or the swimmer will be barred from competition.
7. A “Positive check-in procedure” shall be used for deck seeded events. A swimmer’s intent to swim a race shall be denoted by the swimmer’s or swimmer’s coach’s initials entered next to the swimmers name on the official entry sheet posted at the Clerk of Course.
