SANCTION:	Sanctioned by USA Swimming and Georgia Swimming, Inc. Sanction No.:
HOST:	Athens Bulldog Swim Club
FACILITY:	University of Georgia's Ramsey Center: 50 meter pool with separate warm-up/down pool. 8 lanes will be used for competition. Seating will be provide on bleachers. Ample parking is available.
ELIGIBILITY:	Open to members of ABSC and Gwinnett Aquatics.
RULES:	The 2011 USA Swimming rules will govern the conduct of this meet unless otherwise noted. Swimmers will be responsible for swimming in the proper heat and lane. All swimmers, teams and coaches must be USA-registered and coaches will be asked to show their registration. Officials must wear their USA cards while on deck and must present their Georgia Swimming Officials card to the meet referee upon check-in.
SCHEDULE:	Warm-up will begin at 5:00 pm. The meet will begin at 5:45 pm.
FORMAT:	This will be a timed finals meet. Depending on timelines the 200/500 Free and 200/400 IM may be limited to one heat for each gender.
TIME STANDARDS:	This is an open meet with no time standards.
ENTRIES:	Swimmers may swim a maximum of three events and two relays. On deck registrations will be allowed under current Georgia LSC guidelines.
ENTRY FEES:	There will be a \$20 per swimmer fee for this meet.
ENTRY DEADLINE:	Entries must be in to the Meet Director by Monday, November 14 <sup>th</sup> .
SCORING:	Points will be awarded as follows: Individual events: 9, 7, 6, 5, 4, 3, 2, 1. Relay points will be double the individual points; the top 3 will score
WARM UPS:	Warm ups will be governed by GA Swimming, Inc. guidelines
WAIVER	In granting this approval it is understood and agreed that USA Swimming, Georgia Swimming, Inc., and Athens Bulldog Swim Club shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
