Facility: Cobb Aquatic Center: 10 lane 25 yard competition pool with a separate warm-up/

Warm-down pool. Bleachers are available. The competition course has been certified in

accordance with 104.2.2C(4). The copy of such certification is on file with USA

Swimming & Georgia Swimming. The pool depth at the start end is 4 & 1/2 feet and 4 & 1/2 feet at the turn end. Due to Cobb County Fire Code, folding chairs are not permitted

on pool deck.

Deck Change - Changing, in whole or in part, into or out of a swimsuit (excluding a drag suit) in an area other than a permanent or temporary locker room, bathroom, changing room or other space designated for changing purposes while at a practice, competition, or other pool-related activity. The practice of Deck Changing is prohibited at all USAS Sanctioned events. Swimmers participating in deck changing would be in violation of the USA Swimming Rule

202.2.9I and could be subject to removal from further competition in the meet

**Rules:** The 2015 USA Swimming rules will govern the conduct of this meet. Use of audio or

visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. All swimmers teams and coaches must be USA Swimming

registered. Coaches and officials must wear credentials while on pool deck.

**Schedule:** Warm-up will begin at 1:00 pm. The meet will begin at 2:00 pm.

**Format:** All events will be conducted as timed finals. The meet has no time standards and is

open to all swimmers from Tidal Wave Swimming and Gwinnett Aquatics.

**Scoring:** Individual events will be scored places 1 through 8 with points accordingly to the

9,7,6,5,4,3,2,1 schedule.

**Entry Fee:** \$15 per swimmer

**Entries:** Swimmers may swim a maximum of 4 individual events and one relay. On deck

registration will be allowed under current LSC guidelines. Entries should be mailed/
