LIABILITY:	In granting this sanction it is understood and agreed that USA Swimming, Inc., Georgia Swimming, Inc., and "Columbus Aquatic Club," shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
SWIMMERS WITH A DISABILITY:	Athletes with a disability are welcomed, but advance notice of desired accommodation must be provided to the Meet Referee via, the Necessary Accommodation Form, which should be submitted by the entry deadline. Failure to provide advance notice may limit the host's ability to accommodate all requests. All swimmers with a Disability participating in the State/Championship Meet must have achieved the 2024-2028 USA Swimming B Parallel Time Standards in every event they enter in the meet. Swimmers with a disability follow the same rules for bonus event entry as those for able-bodied athletes. Additional Entry Requirements: Coaches entering swimmers with a disability should submit the Necessary Accommodation Form to the Meet Referee with their entries. Swimmers achieving a 2024-2028 USA Swimming A Parallel Time Standard in prelims each day will qualify to swim those events in Finals. There will be three mixed Swimmers with a Disability heat at Finals each day to be swum (1) at the beginning of the session, (2) after the 2nd event, and (3) after the last individual event.
FACILITY:	Columbus Aquatic Center 1603 Midtown Dr Columbus, Georgia 31906 The 10 lane, 50 meter pool with a depth at the start ends equal to 13 feet and turn end depth equal 5 feet. There will be 4 warm-up/cool-down lanes. Meet host will ensure the required course dimensions.

MEDICAL SUPERVISION:	The Columbus Aquatic Center has a full staff of American Red Cross certified lifeguards trained in using backboards and AEDs. Lifeguards will be on duty throughout the warm-up and competition periods. Rescue equipment and AEDs are on site. MEET FORMAT:	10 & Under and 11-14 B Sessions: ● All events will be contested as LCM. ● Chase Starts may be used. ● All events will be conducted as timed finals. ● All events will be swum slowest to fastest unless chase starts are used, and then, all events will be swum fastest to slowest. ● 10 & U 400 free event will be deck seeded after positive check-in. It will be swum fastest to slowest alternating heats by gender. Swimmers will need to provide their own timers. ● 11-14 400 Free will be deck seeded after positive check-in. It will be swum fastest to slowest, alternating heats by gender. Swimmers will need to provide their own timers. ● Meet management reserves the right to limit 11-12 and 13-14 races that are 200 or longer in Events 101-176 to the fastest 3 heats per event. 11-14 Prelim/Finals: ● All events will be contested as LCM. ● Chase starts may be used in prelim sessions. ● Events 1-74 will be conducted as prelim/finals, except as noted below. ● 400 Free, 400 IM, 800 Free, and 1500 Free will be deck-seeded after positive check-in. All swimmers participating in these events will need to provide their own counters. Swimmers will be required to provide their own timers for heats contested during the prelims sessions and/or Thursday afternoon session. ● The 13-14 800/1500 will be Timed Finals and swum fastest to slowest alternating gender. ● The 11-12 800 Free will be Timed Finals and swum fastest to slowest alternating gender.																																																							

	• The 11-12 200 Backstroke, Breaststroke, Butterfly, 400 Free and 400 IM will be timed final events, with the fastest heat being contested in the Finals session. All other heats will be swum in the prelim session. • The 13-14 400 Free and 400 IM will be a deck seeded event after positive check in. It will be a prelim/final event with TOP 20 from prelims swimming in the finals (B heat/A heat) • The 11-12 400 IM and 400 Free will be swum fast to slow, alternating heats by gender beginning with the second heat of girls, followed by the second heat of boys. The fastest heat will be contested in the Finals session. • 11-12 prelim/final events will have a Consolation Final (B) and a Championship Final (A) to be swum in that order. If an alternate is able to be placed in an A final, they will be allowed to swim as exhibition to fill the heat. • 13-14 events will have a Bonus Final (C), a Consolation Final (B), and a Championship Final (A) to be swum in that order. If an alternate is able to be placed in a B or A final heat, they will be allowed to swim as exhibition to fill the heat. • All Relays will be conducted as Timed Final events. The 200 Free and 200 Medley relays will be contested during Thursday's timed final session, while the 400 Medley and 400 Free relays will be contested at the start of Finals on their respective days. • Events in which a swimmer does not show up for, or compete, will count as one of their daily swims for that day.

ELIGIBILITY:	MEET TYPE: Open Open to all registered USA Swimmers. No swimmer will be permitted to compete unless the swimmer is a member of USA Swimming as provided in <i>USA Swimming Rules and Regulations</i>, Article 302.
ENTRIES:	Daily Event Limit: 11-14 Swimmers may compete in not more than (3) individual events per day. 10 & under athletes may compete in not more than (4) events per day. Any swimmer who competes in more than their daily limit will be disqualified from the last event of the day. A swimmer's failure to compete in a preliminary event will be considered a disqualification per rule 101.1.5 and that event will count towards the daily event limit. Swimmers entered with SCY or SCM qualifying times will be seeded below all swimmers with qualifying LCM times (LSY order). Bonus times will be seeded below qualified times in the same LSY order. Bonus events: Swimmers who have qualified for an event in any session may compete in (3) bonus events during the meet in the 50M, 100M or 200M events (400 meter and above events cannot be a

	bonus event option). Bonus events can be used on any day. Bonus events count towards the daily event limit and must be designated as such on the entry. 11-14 “B” session swimmers can only use bonus events in the B sessions. Bonus events must be marked as such on the event file. Failure to do so will result in the automatic removal of a swimmer from the bonus event and/or subject to proof of time fines. Teams must submit a report that includes bonus swims designated as such. Time Trial Events: Time Trials will be included in the daily individual event limits. All time trials must be set up with the admin referee by 10:30 a.m. each day. Time Trials WILL count towards daily event limits. Relays: Only TWO (2) relays per team are permitted to score; all other relay teams from the same registered club will be considered ineligible to score and will be marked as exhibition. Relay teams must be made up of swimmers from the same club and cannot include unattached swimmers. Deck Entries: Deck entries can be made with the clerk of course up to 30 minutes before the start of the session. In order to maintain a reasonable timeline and to regulate the continuity of the meet, the Meet Director, in consultation with the Meet Management Committee (Meet Director, AG Committee Chair, Meet Referee and a Coach) reserves the right to make the final decisions over chase starts, dive-over starts, breaks, scheduling of Time Trials, and other issues that affect management, versus the conduct of the meet. PROOF OF TIMES:	Swimmers who enter this State Championship meet must have achieved a time equal to or faster than the qualifying standard for each event entered. Times must be achieved between April 1, 2024, and July 13, 2025. The final results for each event will be reviewed by the designated representative appointed by the LSC Chair to determine each swimmer’s eligibility for this meet. If a swimmer fails to achieve the qualifying standard at this meet and cannot prove that he/she achieved the qualifying standard before the entry deadline, then Georgia Swimming, Inc. will invoke a fine of \$50.00 against the team of said swimmer, or against the swimmer, if unattached, for each non-qualifying time. All entry files must be submitted with a proof of times report. Entries submitted without the proof times report will not be accepted. ANY SWIMMER WHO FAILS TO ACHIEVE OR PROVE AT LEAST ONE QUALIFYING TIME WILL ALSO BE FINED FOR ALL BONUS SWIMS ENTERED AT THE MEET.

	The SWIMS database will be the final source document used to verify proof of time for this meet. Failure to pay fines as prescribed by Georgia Swimming Rules and Regulations 7.2, Inc. will result in the barring of said team/individual from participating in any meets until such time as the fine is paid in full. To pay fines, make checks payable to “Georgia Swimming.” Proof of times are not required for relays.
CHECK IN: CLERK of COURSE:	In order to be seeded into deck-seeded events, swimmers must check-in with the Clerk of Course by the times shown below: • Thursday – 3:30 pm • Friday, Saturday, Sunday Prelims – 8:00 am • Friday 10 & under 400 Free – 1:00 pm • Sunday 11-14 B session 400 Free – 1:00 pm Deck entries will be accepted at each session at the start of warm-ups and will close 30 minutes before the session start time. Time trials will close at 10:30 am each day.

All entry files must be submitted with a proof of times report. Entries submitted without the proof times report will not be accepted. Submit entries using Hy-Tek team manager. Entries must include the USA Swimming Club Code and each swimmer’s USA Swimming number, first and last name, age, and seeding time for each event entered.
RULES:	Current USA Swimming Rules will govern this meet. • All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming <u>Minor Athlete Abuse Prevention Policy</u> ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. • On Deck USA-S registration will be permitted at the discretion of the Meet Director and/or Meet Referee. • In compliance with <i>USA Swimming Rules and Regulations</i>, the use of audio or visual recording devices, including a cell phone, is not permitted in the changing areas, restrooms, or locker rooms. Per GA Swimming policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods. • Deck changes are prohibited. • Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a

	member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. • Operation of a drone or any other flying apparatus is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
CREDENTIALS:	Only athletes, USA Swimming certified coaches, and USA Swimming officials, in good standing, will be permitted on the deck. Coaches and Officials should have proof of active USA Swimming membership with them at all times. Parents not working at the meet as a volunteer or other positions are not permitted on deck.
COACHES: COACHES MEETING:	Coaches will be required to sign in at the Clerk of Course desk to verify their credentials, via SWIMS 3.0, are in good standing with USA-S and their respective LSC. OFFICIALS:	Columbus Aquatic Club Hurricanes welcomes visiting officials and apprentices and will appreciate help in officiating this competition. There will be an official's meeting 60 minutes prior to the start of each session. The official's uniform will consist of a white polo collared shirt, navy blue shorts (prelims only), skirts or slacks with white socks and shoes. All officials must present at check-in their current LSC Officials Certification Card; OR a recently completed Apprentice Form; AND proof of current USA Swimming Non-Athlete membership. Credentials will be required for deck access and hospitality. Officials or apprentices requesting certain positions should contact the Meet Referee as early as possible, prior to the meet. Apprenticing as a Starter will not be allowed at this meet. This will be an OQM for N2 advancement or renewal and N3 S&T only. If interested in being evaluated, please complete the Application to work the meet. Application to Officiate
AWARDS:	Medals will be awarded in each individual event and Swimmers with a Disability (SWADS) events, places 1st through 3rd and ribbons 4th through 10th for events 1-74 and all 10 & Under events. Medals will be awarded in each relay event for places 1st through 3rd. An award will be presented to the most outstanding swimmer (top individual scorer), male and female, in each age group (10 & Under, 11-12, 13-14) and Swimmer with a Disability. There will be no awards for 11-14 B session events. The three highest scoring teams in each division will receive awards Division I (XL): 451+ swimmers

	Division II (L): 201-450 swimmers Division III (M): 81-200 swimmers Division IV (S): 1-80 swimmers It is the team's responsibility to pick up awards. Awards not picked up at the conclusion of the meet will be shipped at the request of that team C.O.D. Please remember to pick up your swimmers' awards at the end of the meet to avoid incurring shipping charges.
SCORING:	Events will be scored to 20 places for all age groups (10 & U, 11-12, 13-14); Relays will be scored to 20 places. Swimmers and relays that do not achieve the meet qualifying time in an event cannot score points in that event. B session events are timed final, non-scoring events. Individual Events: 24-21-20-19-18-17-16-15-14-13-11-9-8-7-6-5-4-3-2-1 Relay Events scored are doubled: 48-42-40-38-36-34-32-30-28-26-22-18-16-14-12-10-8-6-4-2 Swimmers with a disability will be scored in their own mixed-age, mixed-gender scoring group. The formula for scoring this group is posted on the Georgia Swimming website.
