

**GA vs DAQ Dual Meet**  
**March 15<sup>th</sup>, 2008**

- SANCTION:** Approved by USA Swimming and Georgia Swimming, Inc. Approval No.:
- HOST:** Gwinnett Aquatics will host the meet at the Mountain Park pool, a 25-yard x 10 lane pool. Manual timing will be used.
- ELIGIBILITY:** Open to members of Dekalb Aquatics and Gwinnett Aquatics.
- RULES:** The 2008 USA Swimming rules will govern the conduct of this meet unless otherwise noted. Swimmers will be responsible for swimming in the proper heat and lane. All swimmers, teams and coaches must be USA-registered and coaches will be asked to show their registration. Officials must wear their USA cards while on deck and must present their Georgia Swimming Officials card to the meet referee upon check-in.
- SCHEDULE:** Warm-up for the host will begin at 6pm. The meet will begin at 6:45pm.
- FORMAT:** This will be a timed finals meet.
- TIME STANDARDS:** This is an open meet with no time standards.
- ENTRIES:** Swimmers may swim a maximum of three events and one relay. On deck registrations will be allowed under current Georgia LSC guidelines.
- ENTRY FEES:** There will be a \$12 per swimmer fee for this meet.
- AWARDS:** Ribbons will be awarded to top eight finishers in 12&Under events, heat winner ribbons to all 12&U heat winners.
- ENTRY DEADLINE:** Entries must be in to the Meet Director by Tuesday, March 1 2007.  
12U events will be scored for 10U and 11-12. Open Events will be scored for 14U and Senior.
- SCORING:** Points will be awarded as follows:  
Individual events: 9, 7, 6, 5, 4, 3, 2, 1.  
Relay points will be double the individual points.
- CONCESSIONS:** Concessions will be available.
- WAIVER** In granting this approval it is understood and agreed that USA Swimming, Georgia Swimming, Inc., and Gwinnett Aquatics shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. (USA Swimming, Rules and Regulations, 2004, 202.4.10.)
