This meet will be conducted under the auspices of Southeastern Swimming, Inc. of USA Swimming. USA Swimming technical rules and regulations will be followed with the exception of items specifically addressed in the meet information Sanctioned by Southeastern Swimming, Inc. Held under the sanction of USA Swimming and Southeastern Swimming, Inc.

HOST CLUB: Tennessee Aquatics

LOCATION: Allan Jones Intercollegiate Aquatic Center-University of Tennessee

FACILITY: 50-meter competition courses (maximum of 8 lanes course) with slanted starting blocks (28 inches above the water surface). Pool depth is 8 feet at ends, 9 feet in the center. Lanes are 9 feet wide formed by 6 inch Competitor lane markers. Warm-up/warm-down pool is located adjacent to the competition pool, with a minimum of two separate 25- yard warm-up/ warm-down lanes available (up to 6 lanes). Seating for 1,284 spectators in the balcony overlooking the pool. Only coaches and athletes are permitted on the pool deck, locker rooms are adjacent to the pool. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

Prelim Sessions:

MEET SESSIONS: Warm-Up: 7:00-8:50am

Competition: 9:00am

Finals Sessions:

Warm-up: 4:30-5:50pm

Competition: 6:00pm

NOTES: Possibility that warm-up and competition start times will be made earlier for the finals session on Sunday. All warmo up start and end times and duration of warmo ups may be adjusted at the discretion of the Meet Director. **On deck USA registration will not be allowed.**

WARM-UPS: SES Warm-up procedures and Meet Safety Guidelines will be in effect. The Meet Director will post warm-up lane assignments prior to the start of the meet. Swimmers attending the meet without a coach must report to the Meet Director or Referee to be assigned a coach for warm-up prior to each session.

INDIVIDUAL EVENTS:

- Timed finals for all 10&U events.
- Prelim/Finals for 11-12, 13-14, & Senior age groups.
- Age on the first day of competition determines age group for the entire meet.
- Prelims will be swum SCY and Finals will be swum LCM.

RELAY EVENTS: All relays are timed finals and will be deck seeded.

- 10&U Relays will be swum in the prelims sessions, heats swum slowest to fastest.
- 11-12, 13-14, Senior & Open relays will be swum in the finals sessions, heats swum fastest to slowest.
- · Teams are limited to two relay entries in each relay event
- 10&U Relay cards must be submitted to Clerk of Course by the start of the Preliminary session on the day of the event.
- 11-12, 13-14, Senior relay cards must be submitted to Clerk of Course by 5:15 p.m. the day of the event.
- Open 200 Free Relay and Open 200 Medley Relay cards must be submitted to Clerk of Course by warm-ups the day of the event.
- Relay cards must have each swimmer's first and last names and must be presented in the order in which the swimmers are to swim in the relay.
- We reserve the right to split the relay heats and swim them in 2 courses during the prelims and finals sessions.

SESSIONS: Prelims will be swum in SCY in an 8 lane course and one 8-10 lane course. Finals will be swum in LCM in a single 8 lane course as follows:

11-12 age group – A Final, 13-14 age group – A & B Final, Senior age group – A, B & C Final

- Exceptions:
- 11-12 500 Free is a deck-seeded timed final event swum in the Preliminary session fastest to slowest.
- 13&Over 1500 & 800 Free are timed finals, swum in the Preliminary Distance session fastest to slowest, except for the fastest heat which will be swum in Finals.
 Swimmers will indicate at positive check in if they are available to swim the 1500 during the preliminary distance session *only* by marking "AM ONLY" next to their initials.
- 13-14 400 IM and 500 Free will swim only an A Final.
- Senior 400 IM and 500 Free will swim only an A & B Final.

SEEDING: Individual events will be pre-seeded.

Exceptions:

- 500 Free, 1500 Free, 800 Free & 400 IM will be deck seeded.
- The fastest three heats of each of the 13-14 and Senior 500 Free & 400 IM will be circle seeded.
- The 13&Over 1500 Free & 800 Free will be swum fastest to slowest one hour after the conclusion of the preliminary session, with the fastest heat being swum at finals.
- For the 500 Free, 1500 Free, 800 Free & 400 IM swimmers must sign-in with Clerk of Course prior to the start of the Preliminary session on the day of the event. If a swimmer is not checked in with Clerk of Course, the swimmer is legally scratched from the event.
- There is no penalty for not swimming a deck-seeded event.

FLIGHTED PRELIMINARIES: Based on the number of entries, the 400 IM and 500 Free may be flighted at the discretion of the Meet Director. In the event that either or both of these events are flighted, the following will occur:

- After positive check-in, the fastest 3 heats in each 13-14 event and the fastest 3 heats in each Senior event will be circle seeded and swum in an "A" Flight of prelims in normal event order. All remaining entries will be swum in a "B" Flight. The "B" Flight will be swum fastest to slowest in normal event order. All swimmers in the "B" Flight should be prepared to provide a timer for their lane, if needed.
- The Meet Director and Meet Referee reserve the right to adjust the timeline in any way deemed proper to facilitate the operation of the meet, including the right to insert 10 minute breaks where appropriate in the meet timeline.

ELIGIBILITY: All swimmers must be registered with USA Swimming or the swimming federation of their representative country. No entries will be accepted without current USAS registration numbers (or their international equivalents).

TIME STANDARDS: The 2016 Southern Premier Time Standards are as follows:

- Out of Southeastern LSC Swimmers:
 - Age Group Time Standards: 2016 Eastern Section of the Southern Zone Age Group Sectional Time Standards
 - Senior Time Standards: 2016 Eastern Section of the Southern Zone Senior Sectional Time Standards
- Southeastern LSC Swimmers:
 - o 2016 Southeastern Swimming Championships Time Standards

Swimmers must have a qualifying time for one or more of their individual events to be eligible to swim the meet. All entry times must be proven.

Bonus events will be permitted for this meet. All athletes who qualify for one or more individual events will be permitted to enter and swim in up to two bonus events total for the entire meet.


Exceptions:

- Swimmers in all age groups must have a qualifying time in the following events to be entered in that event: 200 Free, 500 Free, 1500 Free 800 Free, 200 IM, 400 IM.
- There will be no time standard for relays.

ENTRIES: All swimmers may enter and swim no more than three individual events per day and no more than seven individual events in the entire meet.

Teams are to submit entries to Victoria Klouda via email at meetdirector@tnaquatics.com.

HYTEK event file, psych sheets, daily results and other meet information will be posted at www.tnaquatics.com as it becomes available. Entries from individual athletes will not be accepted. All entries must come from a coach associated with each club, and the use of a HyTek entry file is highly encouraged.



DECK ENTRIES: Deck entries and changes will be accepted for available lanes on a first-come, first-serve basis pending lane availability. No new heats will be formed. Coaches can make these arrangements and pay on deck at the Clerk of Course.

ENTRY DEADLINE: All entries and entry materials must be received by **Tuesday, February 23rd at 6:00 p.m.** Hardcopy, check, entry summary and release should be mailed for entry to be considered complete. Please waive need for signature on any express mail, Federal Express, UPS, etc.

** This meet has been designated an Officials Qualifying Meet (OQM) for national certification. Those requesting N2/N3 evaluations need to complete the USAS application and forward to the Meet Referee. No official will be permitted to work during a session unless they have filled out an "Application to Officiate" form and been accepted by the Meet Referee

DISABLED SWIMMERS: Check in with the Meet Director upon arrival and submit attached Disabled Swimmer Form.

TIME TRIALS: Time trials may be held upon reasonable request at the discretion of the meet referee. Such swims will be held after the finals session each night and, time permitting, after the morning preliminaries each day. Fees for time trials shall be \$8.00 per individual event and \$16.00 per relay. Swimmers swimming prelim/finals may not exceed a total of three individual events, including time trial events and bonus events, per day. Swimmers swimming timed final events only may not exceed a total of five individual events, including time trial events and bonus events, per day.

SCRATCHES: Swimmers qualifying for finals and consolation finals must notify the Clerk of

Course within 30 minutes of the announcement of the finals qualifiers for that event if they do not intend to compete.

Any swimmer qualifying for a final or consolation final race in an individual event who fails to compete in such final race shall be barred from swimming his or her next individual event of the competition, unless such failure to compete is excused by the meet referee for cause. This penalty shall apply to individual events only, and shall not apply to relay events.

AWARDS: Awards will be given for 1st – 8th place for individual events and 1st – 3rd place for relays. There will be team awards for the top 3 teams in Senior, Age Group and Combined team categories.

MEETINGS: If a coaches meeting is deemed necessary, the Meet Director will provide information regarding time and location at coaches' check-in. Timers will meet 30 minutes prior to each session. Officials will meet 1 hour prior to every session for briefings.

SPECIAL NOTES: In accordance with Southeastern Swimming Guidelines, overhead starts, whistle starts, and the "no recall rule" will apply.

The Meet Director reserves the right to combine heats and/or events, limit any event, or run any session in two pools in order to facilitate the conduct of the meet and to run the meet within the time allocated. May also shift age groups in pools during the prelim/finals to conduct meet within the time allocated.

Swimmers signing in for a deck seeded event and not swimming will be scratched from their next event unless relieved by the Meet Referee for cause.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms, or on deck.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Coaches shall display, in an obvious location, their USAS membership cards to be allowed on deck at any SES sanctioned meet. Compliance shall be the responsibility of the Host Meet Director. Check-in will be at Clerk of Course.

SAFETY: Coaches, swimmers and spectators are asked to observe all posted pool rules and conduct themselves in a safe and prudent manner. Southeastern Swimming Meet Safety Guidelines and Warm-up Procedures will be in effect.
